For American Funds, Principal Funds, and some other funds (check the 403bCompare list), you can continue making contributions through a custodial account with 403bASP (ASPIre Financial Services), variable annuities or other custodial accounts. You must select an option available through CalSTRS 403bComply so that we are sure the Vendor you choose has agreed to the terms of your Employer's Written Plan and to provide data to CalSTRS 403bComply electronically.

403b ASP (ASPIre Financial Services) and similar options typically charge additional fees for this service so you will have to determine if this is worthwhile.

IMPORTANT NOTE: If you want to keep contributing to your 403(b) fund through payroll and you choose one of the alternatives above, you must stop your deduction to the fund and change the deduction to the alternative product.
